### **CHRISTMAS GREETING**

Negotiating skills for landmen have been tested at length during 2011. The Utica-Collingwood formation play of 2010 drove lease prices up to \$2,000 per acre and above. Then within a period of one week, the leasing play came to an abrupt halt. Although EnCana Oil & Gas is still drilling and fracing wells in Kalkaska County, the Utica-Collingwood play suffered serious setbacks due to lack of production from the initial wells drilled.

A number of Michigan landmen have been actively working Devon Energy's Silurian A-1 Carbonate play which originated in Gladwin County but has since spread to many counties in the central 1/3 of Michigan. As you already know, lease prices are somewhat back to normal or maybe just a little higher than normal. As more wells are drilled, we will discover whether Michigan land and mineral owners will be as lucky as their counterparts in West Virginia, Pennsylvania, New York and Ohio. Neighboring states have witnessed lease prices climbing to over \$5,000 per acre. All we can do is wait and see, and of course hope.

One thing for sure is the Christmas holiday season is upon us. It is the season for joy and celebration. #### Oil and Gas Lease Priority

Mortgage subordinations are title curative items that landmen deal with in nearly every title opinion they work on. In some instances if the requirement is not satisfied a company may determine the risk is too great to drill a new well. Recently it has been suggested that a priority mortgage on a newly leased tract can constitute a title defect and therefore release the Lessee from the obligation of paying the bonus consideration and resulting in termination of the lease offer.

On June 30, 2010 Ohio enacted a significant amendment to their Oil and Gas Laws with one part of the amendment being a section that allowed oil and gas leases, pipeline easements and other documents related to the production and sale of oil and gas that are subordinate to recorded mortgages or other liens to have priority over those liens. The result is those oil and gas documents cannot be terminated in the event of a foreclosure of the mortgage or lien, provided the documents are in good standing. The 2010/2011 MAPL board discussed this issue early in 2011 and in June of 2011 through MOGA Legal & Legislative committee member Gary Worman made a request to the MOGA committee to explore the viability of lease priority legislation and whether MOGA would take the initiative to pursue a statute. MOGA's Legal & Legislative committee agreed to pursue the issue and have prepared a draft amendment to the Mortgage and Land Contracts foreclosure statute Parts 31 and 32 of the Michigan Revised Judicature Act. There are several more steps that remain in the process before a lease priority bill can be introduced to the legislature, but progress toward that goal is being made. We will keep you posted.
