CHECK IT OUT! MAPL ROLLS OUT NEW WEBSITE

We are pleased to announce the new look of the MAPL website (www.michiganlandman.com) and hope that you will have better usability in all features! I have a short write-up on how to achieve the best results when using the site.

- 1. Under the "Calendar" tab, you will find the upcoming MAPL events for the month. The calendar is navigable by month. By clicking "Open Calendar" you will find the events currently posted. When these events go live, you will be able to view details and register for the events.
- 2. Under the "Members" tab, you will be required to use only a password to access.. What you will find on the Member's page, are the following:
 - a. Membership Renewal/Application Form
 - b. Membership Directory
 - c. Cvent Member Portal

The Cvent Member Portal is the software we use to plan events and manage each member's individual information. This portion is important for you, in the event you have changes to your contact details (phone, address, etc.) you can change them here. Click the link, either you have signed-up through Cvent Member Portal before, all you will need to do is Log In, if not, please Sign Up.

Once entered, you will have the ability to:

- i. Edit certain contact information and/or renew membership in "My Profile & Membership"
- ii. View a history of your attended events in "My Events"
- iii. View the searchable Member Directory

"INDEPENDENT CONTRACTOR STATUS"

ACT 241 of 2014 / HOUSE BILL 4958 NOW LAW!

The law clarifying and protecting the Independent Contractor status of Oil and Gas Landman has been passed by both houses of the Legislature and signed by the Governor. The legislation takes effect August 26, 2014.

An Excerpt from the legislation related to Oil and Gas Landmen:

(v) Service performed by an individual as an oil, gas, or mineral landman under a contract with a private person or private entity if substantially all remuneration, including payment at a daily rate paid in cash or otherwise for the performance of the service, is directly related to the individual's completion of the specific tasks contracted for rather

than the number of hours worked, and if the contract provides that the individual is an independent contractor and not an employee with respect to the contracted service. As used in this subdivision, "landman" means an individual who is engaged in 1 or more of the following:

- (i) Negotiating the acquisition or divestiture of oil, gas, or mineral rights.
- (ii) Negotiating business agreements that provide for the exploration for, transportation of, or development of oil, gas, or minerals.
- (iii) Determining the ownership of oil, gas, or minerals through research of public and private records.
- (iv) Reviewing the status of the title to, and curing title defects and deficiencies associated with, the ownership of oil, gas, or minerals.
- (v) Managing rights or obligations derived from the ownership of interests in oil, gas, or minerals.
- (vi) Interacting with regulatory agencies in support of activities relating to exploring for and producing oil, gas, or minerals.
